He presided the National Commission of Fight Against Drugs (CNLD), the National Commission for the Control and Regulation of Firearms, Ammunitions, Explosives and other materials. He was the Chairman of the Board of the Institute of Social Security and Human Development (ISSDHU), President of the National Commission of Highway Education, and also Coordinator of the National System for Prevention, Mitigation, and Attention to Disasters (SINAPRED).

Dr. Fiallos held the position of National Director of the support plan for the Development and Strengthening of the Attorney General Office of the Republic of Nicaragua under the program of the United Nations for Development, known as project (PNUD-Nic /02/16-PGR.
